

**THE TOWN OF MINNEDOSA
ANNUAL SCHEDULE OF FEES BY-LAW NO. 2613C**

AS AMENDED by BY-LAW NO. 2619

BEING A BY-LAW of the Town of Minnedosa to adopt the Annual Schedule of Fees for services, activities or things provided by the Town of Minnedosa.

WHEREAS in accordance with Section 232(2) of The Municipal Act. S.M. 1196 Cap. 58, C.M. 225 a municipality may, in a by-law, establish fees or other charges for services, activities, or things provided or done by the municipality;

AND WHEREAS Section 236(1)(iii) provides that an amount owing under subclause (ii) may be collected in any manner in which a tax may be collected or enforced under this Act.

AND WHEREAS it is deemed necessary and expedient to establish a new schedule of fees for the services and activities provided by the Town of Minnedosa;

NOW THEREFORE the Council of the Town of Minnedosa, duly assembled, enacts as follows:

1. This By-law shall be referred to as the "Annual Fee Schedule By-law"
2. The fees shall be established in accordance with the regulation hereto.
3. That Council from time to time may review and amend.
4. Solid Waste and Recycling Collection and Disposal fees, as set out in this by-law shall be billed on a quarterly basis and included on the Utility bills for the premise. Each collection will be identified separately on the Utility bill. Excluding the 2025 year in which the fees shall be collected during the last two quarters of the Utility cycle.
 - a. Where collection service does not commence on the first day of the month of the applicable billing quarter, the service fees will be prorated to the date of commencement.
 - b. Where partial payment is made on a Utility bill, payment will first be applied to the water and sewer charges, if applicable, and then to the Solid Waste and Recycling Collection and Disposal Charges.

5. This By-law shall come into full force and take effect on the day following the date of passage
